

**ORDINANCE NO. 16-16**

**BOROUGH OF NORTH PLAINFIELD  
COUNTY OF SOMERSET  
STATE OF NEW JERSEY**

**AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT  
THE BOROUGH CODE OF THE BOROUGH OF NORTH PLAINFIELD,  
CHAPTER XIX ENTITLED, "FIRE PREVENTION",  
SECTION 19-2 ENTITLED,  
"LOCAL ENFORCEMENT",  
SPECIFICALLY, SECTION 19-2.4A ENTITLED,  
"NONREGISTERED LIFE HAZARD USE FEE",**

**WHEREAS**, the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey believes that it is in the best interest of the Borough to amend, revise and supplement Chapter XIX of the Borough Code of the Borough of North Plainfield, entitled "Fire Prevention"; and,

**WHEREAS**, the Borough of North Plainfield, County of Somerset, State of New Jersey is authorized by State law to make rules regarding the fees charged for certain inspections by the North Plainfield Fire Department within the Borough; and,

**WHEREAS**, the Borough of North Plainfield, County of Somerset, State of New Jersey has determined that the public health, welfare and safety needs to be protected by requiring certain inspections to ensure fire safety and to enforce the New Jersey Uniform Fire Code within the Borough of North Plainfield and to provide for the monies necessary to carry out said inspections; and,

**NOW, THEREFORE, BE IT ORDAINED** by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that Chapter XIX, Section 19-2.4A of the Borough Code of the Borough of North Plainfield, entitled "Nonregistered Life Hazard Use

Fee”, is hereby amended, revised and supplemented by increasing the fee from Thirty Dollars (\$30.00) to Fifty Dollars (\$50.00).

**NOW, THEREFORE, BE IT FURTHER ORDAINED** that:

1. All ordinances or portions of ordinances that are inconsistent with this Ordinance shall be repealed as to their inconsistencies only.

2. If any provision or paragraph of this Ordinance shall be held invalid by any court of competent jurisdiction, the same shall not affect the other provisions or paragraphs of this Ordinance, except so far as the provision or paragraph so declared invalid shall be separable from the remainder or any portion thereof.

3. This Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to *N.J.S.A. 40:69A-181(b)*, declaring an emergency and providing that this Ordinance shall take effect at an earlier date.
