The following is a report of the activities of the North Plainfield Police Department for the month. The Divisions of the Department divide the report.

ADMINISTRATION:

Staffing:

The Police Department is operating below its authorized strength of 48 sworn Officers, and 6 fulltime civilian personnel. Staffing and deficiencies:

- 3 police officers
- 1 Lieutenant's position
- 2 administrative assistants (chief and records) have been reduced to 29 hour parttime positions.

Injured Officers:

No Officer injuries reported during February.

Promotions, New Hires and Retirements

- On February 28, Hope Arthur resigned from her position as a dispatcher with the North Plainfield Police Department.
- On February 29, Jordan Rogers was sworn in as a probationary Patrol Officer. He will graduate the Camden County Police Academy on March 22.
- There were no promotions during the month of February.

A Sample of Investigations & Arrests

On February 2, 2016 an arrest was made of a Boro resident who was the target of a multi-agency task force for doing apartment burglaries. The task force was following the suspect and as he committed a burglary in North Plainfield he was arrested. He was charged with that burglary and multiple others in our town, Piscataway, Edison, Middlesex and Plainfield. He is currently in the Somerset County Jail awaiting court proceedings.

On February 8, 2016 during the course of a motor vehicle stop for motor vehicle violations two suspects were arrested during the investigation and 147 bags of heroin were located along with other items indicative of drug dealing. Both suspects were charged with Possession of a Controlled Dangerous Substance and Possession of a

Controlled Dangerous Substance with intent to Distribute. Both suspects were turned over to the Somerset County Jail and are awaiting court proceedings.

On February 21, 2016 patrol units responded to 403 Somerset Street for a dispute where the suspect was being detained by civilians after he assaulted one other male. The investigation revealed that after a dispute in the parking lot of an establishment the suspect retrieved a baseball bat from his car and struck the victim once in the head. The victim was transported to an area hospital for treatment and the suspect was charged with Aggravated Assault and Possession of a Weapon for an Unlawful Purpose. The suspect was turned over to the Somerset County Jail and is awaiting court proceedings.

Narcotics Strike Force

Officer Kropewnicki and members of the Narcotics Strike Force spent a total of 54 man hours in the Boro conducting surveillance and trying to obtain narcotics information. An arrest of a suspect was also made and he was charged with possession of Heroin and possession with intent to distribute.

Other Matters

The Detective Bureau conducted background investigations for two Raffle requests, 7 Firearms investigations, one taxicab license, one limousine investigation and one vendor license. Two members of the Detective Bureau attended and completed Krav Maga Knife Defense class.

Adjudications & Judicial Proceedings

Members of the Detective Bureau testified before the Superior Court Grand Jury on three occasions and in other court proceedings twice in February.
