ADMINISTRATION:

Staffing:

The Police Department is operating below its authorized strength of 48 sworn Officers, and 6 fulltime civilian personnel. Staffing and deficiencies:

- 2 police officers
- 1 Lieutenant's position
- 1 administrative assistant (Records), has been reduced to a 29 hour part-time position.

Injured Officers:

- Officer Brid continued to work on light duty since March 27, 2017, due to surgery he had on November 3, 2016; a result of an on duty accident he had on December 9, 2014. As of April 30, he was out of work for 117 days and on light duty for 276 days.
- Officer Jean-Baptiste was placed on administrative leave March 6, 2017, due to a complaint requiring an investigation. As of April 30, he was out of work for 222 days.

CID Monthly Report

A Sample of Investigations & Arrests

On May 15, 2018 at 1:00 AM police were called to the 50 block of Watchung Ave on the report of a pedestrian struck by a motor vehicle. The suspect vehicle had fled the scene immediately after striking the victim. The victim was killed almost immediately and had massive head and body trauma. Detectives and the Somerset County CART Team were called and began to investigate the crash and collect any potential evidence. Detective's located evidence left behind by the suspect vehicle and almost immediately were able to identify the make, model and year of the vehicle. Video surveillance was collected from numerous locations throughout North Plainfield and Plainfield that assisted detectives in identifying the route travelled by the suspect after he struck the victim. Detectives urged the public for assistance and used social media as a platform which payed off on May 17, 2018 just two days after the crash. On that date detectives located both the suspect vehicle and witnesses that identified the driver. Detectives recovered additional telephonic evidence that again identified the driver and his knowledge of the accident. The driver unfortunately left the United States the day after the accident, however

detectives have identified him and have charged him with 2C:11-5.1 Knowingly leaving the scene of an accident resulting in death, a 2nd degree crime.

On May 1, 2018 at 1:00 PM police were called to a local check cashing business on Somerset Street on the reported assault victim who was unconscious. The victim, a North Plainfield resident had been viciously assaulted and had almost no memory of the incident as a result of the beating he had endured. Detectives immediately retrieved video surveillance which captured the entire incident as well as the suspect. Detectives obtained additional business records which provided the suspects name and telephone number allowing police to track him down. The suspect, a Plainfield resident was interrogated in CID and provided detectives with a post Miranda statement admitting to the assault. The Somerset County Prosecutors Office was contacted and authorized a charge of Aggravated assault 2C:12-1b 3rd degree and Criminal mischief 2C:17-3 DP.

On May 3, 2018 at 4:00 AM police were called to a burglary in progress on Washington Ave. Patrol officers were given a description of the suspect and located a male in the immediate area that matched the given description. The male was detained and a detective was dispatched to the scene. Detectives interviewed the victim and obtained video surveillance that captured the suspect entering a vehicle. The victim positively identified the suspect and the suspect was then interrogated in CID. The suspect admitted to detectives in a post Miranda statement that he had entered the victim's vehicle without permission. The Somerset County Prosecutors Office was contacted and authorized a charge of 2C:18-2 Burglary 3rd degree.

On May 3, 2018 detectives began a complicated fraud investigation at a North Plainfield beauty school. An employee of the school had allegedly received a payment from a school student to assist in fraudulently receiving almost \$4000.00 in illegal funds. Detectives learned through investigation that the employee forged a signature on both a New Jersey State certification and a degree for Cosmetology. The employee also provided falsified records to the student indicating that she worked 159 hours. Detectives interviewed numerous witnesses and subpoenaed records which all led to the suspect. The female suspect was interrogated in CID. The Somerset County Prosecutors Office was contacted and authorized charges of fraud 2C:21-1a 3rd degree against the suspect.

Community Outreach

The Community Policing unit made twenty five (25) calls to the senior citizens enrolled in the Good Morning program, and sent out fifty four (54) first time false alarm activation notices. Det. Domizi attended a North Plainfield community forum meeting on May 3, 2018 and a Municipal Alliance meeting on May 22, 2018. Det. Domizi also attended a child seat recertification class on May 10, 2018 and taught DARE on May 29, 2018.

Narcotics Strike Force

During the month of May the Narcotics Strike Force officer has been assigned to a Title III investigation (wiretap) which is currently ongoing. Wiretap investigations can be lengthy and consume several man hours; however they can generate numerous arrests and large drug seizures at their conclusion. Ofc. Dow will be attending "Top Gun" narcotics school at the Bergen County Police Academy from June 9th through June 15th.

Other Matters

Detectives attended mandatory agency training on both May 11th and May 16th. Training consisted of mandatory firearms qualifications at the range as well as Use of Force and Pursuit Training. Detective Segeda taught Use of Force to officers on both training dates. Detectives Fowler and Domizi attended a meeting at the SCPO on May 8, 2018 which covered current gang trends in Somerset County. Detective Mazza participated in the Police Unity Tour to raise awareness for Law Enforcement Officers who have died in the line of duty. Det. Mazza rode from New Jersey to Washington DC with hundreds of other law enforcement officers.

Detectives investigated a total of fifteen separate licensing / background investigations during the month of May. Five of these investigations concerned Firearms applications and pistol permits, two Taxi license, one vendor licenses, two raffle licenses and two land use permits. Detectives also completed two separate background investigations on potential probationary police officers and one Parking Authority employee. Lt. McKay completed the annual mandatory registration of two separate Megan's law offenders.

Adjudications & Judicial Proceedings

Det. Domizi appeared in a juvenile trial in Trenton NJ on May 16, 2018. Det. Everett appeared in Grand Jury on May 17, 2018 in the State v Johnson. Det. Domizi appeared in Grand Jury on May 24, 2018 in the State v Noe Guardado-Cantor.

Eric Talley was ordered by the court to pay \$800.00 is restitution for his part in a Costco cash card scheme. Norman Hurdle was sentenced to six years in State Prison by the court and ordered to pay \$400.00 in restitution for his involvement in numerous garage burglaries in North Plainfield. Marion Irving was sentenced to ten years in State Prison for his involvement in an armed robbery of a North Plainfield resident in March 2017.Robert Mairura was sentenced to thirty days in jail and was ordered to pay \$10800.23 in restitution for his involvement in a check scheme at a North Plainfield rental business. Raekwon Billups was sentenced to two years' probation as a result of his guilty plea for joy riding.
