ADMINISTRATION:

Staffing:

The Police Department is operating below its authorized strength of 48 sworn Officers, and 6 fulltime civilian personnel. Staffing and deficiencies:

- 4 police officers
- 1 Lieutenant's position
- 2 administrative assistants (chief and records) have been reduced to 29 hour parttime positions.

A Sample of Investigations & Arrests

During September the agency began posting information and requests for assistance from the public on the Borough FaceBook page along with a "TIPS" email address. It appears to be a welcomed thing from residents who follow the page. We posted our first request for assistance in identifying a suspect from a shoplifting at Quick Chek and the next day the suspect was identified by a resident and when the family was contacted by a detective his mother saw the post and identified the suspect as well.

One of our first informative posts was an alert for the East Side of town to pay attention to two women who were going door to door asking for some type of diversionary request to get inside the home. If the homeowner allowed one or both in the suspect(s) would then steal items that were able to be concealed on their person. Within a day of two of these cases the post went up and the next day we received a call of the suspects attempting to do the same thing. Both suspects were detained, identified and we have sent the cases to the Somerset County Prosecutors Office and are awaiting charges for the suspects in these cases.

Community Outreach

In September school began and the Community Policing Unit began their school activities with DARE and GREAT. Detective Fowler is a constant presence in the high school while in session he is also conducting all investigations from reports generated at the schools in the Boro. The Good Morning Program made 12 calls to various senior citizens enrolled in the program. 17 first time false alarm activation notices were sent out along with 11 false alarm warning notices. Detective Domizi completed 19 Spanish to English translations for the department as well.

Narcotics Strike Force

The Narcotics Strike Force spent approximately 17 man hours in the Boro doing surveillance and gathering information on narcotic activity. During that time several citizen complaints were addressed with members of the Strike Force speaking directly to the complainants. Officer Kropewnicki attended a one-week Tactical Interviewing course at the Somerset County Police Academy in September.

Other Matters

The agency and state as a whole have now changed the way complaints for criminal offenses are typed and completed due to the Administrative Office of Courts. With this change, as with anything new, cases where adults are arrested are taking longer to process the paperwork. The department as a whole are learning and adjusting to all of the changes, some are occurring as we go, without any complaints and I feel they should all be commended. During September the Detective bureau did two background investigations, one for a firearms ID card and one for a raffle.

Adjudications & Judicial Proceedings

During September members of the Detective bureau testified before the Superior Court Grand Jury twice and had two Superior Court hearings. Members also were in Municipal Court on two occasions. On September 12, 2016 Superior Court Judge Reed sentenced Francell Beal to one year in prison for a Burglary to a car arrest made by patrol and followed up on by detectives. Also on the same day Superior Court Judge Bury sentenced Abraham Slater to one year in prison for Possession of Controlled Dangerous Substances in which he was stopped by patrol and found to be in possession of a quantity of drugs.
