Notice to Recreation Department Activities: This notice is to advise you that under the New Jersey state law, the Borough of North Plainfield, along with all municipalities, are protected against law suits under a statute known as title 59. As a result, if you are injured during any of the Borough's activities, you will most likely be unable to recover any damages through litigation. Since we do not provide any kind of accident insurance, and in view of the above, it is our suggestion that you be certain that you are covered under your own health insurance plan. We are providing the above information to you purely as a service. From past experience we do realize that many participants are unaware of the protection provided to all public entities under the law. As a result, we have had in the past, participants who have been injured during athletic activities sponsored by the Borough of North Plainfield who have not had the proper insurance coverage. Therefore we suggest you review the above and be certain that you have your own insurance coverage for yourself.

Notice to Non-Recreation Department Activities: This notice is to advise you that the borough does not maintain insurance to cover your permit use. It is the responsibility of the organization to provide insurance coverage for their activity. This permit is void if the insurance section is not signed off by a borough official.
