

- 5. Trash receptacles shall be emptied daily.
- 6. If awnings or umbrellas are used, they shall be washed whenever they become dirty.
- 7. Applicant must not block adjacent doorway with any tables, chairs or planters, and must maintain six (6) feet of clear space between tables/planters and curb and/or structures to ensure A.D.A. compliance.
