WHEREAS, the Borough of North Plainfield was in need of a professional engineer to provide certain General Engineering Services for the period between May 1, 2016 and April 30, 2017; and,

WHEREAS, the Borough of North Plainfield previously passed a resolution authorizing the Mayor and Borough Clerk to execute a professional services agreement with Mott MacDonald, with its principal place of business located at 3 Paragon Way, Freehold, New Jersey 07728, as it was in the business of providing Engineering Services and previously submitted a proposal for 2016-2017 General Engineering Services with a Budget limit of Two Hundred Sixteen Thousand Five Hundred Dollars (\$216,500.00); and,

WHEREAS, Mott MacDonald did perform Engineering Services for the Borough of North Plainfield for a period between May 1, 2016 and April 30, 2017; and,

WHEREAS, Mott MacDonald by way of letter dated June 20, 2017, claims to have incurred expenses for said services in a total of Two Hundred Twenty-Five Thousand Two Hundred Fifty Dollars (\$225,250.00), a copy of said letter being maintained in the Office of the Borough Clerk, the contents of which are incorporated herein; and,

WHEREAS, the Borough of North Plainfield is desirous of amending the authorizing resolution and the Professional Services Agreement to raise the budget limit to Two Hundred Twenty-Five Thousand Two Hundred Fifty Dollars (\$225,250.00) to compensate Mott MacDonald for those costs incurred performing Engineering Services for a total increase of Eight Thousand Seven Hundred Fifty Dollars (\$8,750.00).

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey, that the Borough Council does hereby authorize the Mayor and Clerk to execute an Amended Professional Services Agreement to reflect the increased amount of the budget in said Agreement from Two Hundred Sixteen Thousand Five Hundred Dollars (\$216,500.00)

to Two Hundred Twenty-Five Thousand Two Hundred Fifty Dollars (\$225,250.00), with a total increase of Eight Thousand Seven Hundred Fifty Dollars (\$8,750.00).

WHEREAS, the Borough of North Plainfield was in need of a professional engineer to provide certain General Engineering Services for the period between May 1, 2016 and April 30, 2017; and,

WHEREAS, the Borough of North Plainfield previously passed a resolution authorizing the Mayor and Borough Clerk to execute a professional services agreement with Mott MacDonald, with its principal place of business located at 3 Paragon Way, Freehold, New Jersey 07728, as it was in the business of providing Engineering Services and previously submitted a proposal for 2016-2017 General Engineering Services for the period between May 1, 2016 and April 30, 2017; and,

WHEREAS, Mott MacDonald did perform Engineering Services for the Borough of North Plainfield for a period between May 1, 2016 and April 30, 2017; and,

WHEREAS, Mott MacDonald, by way of letter dated June 20, 2017, requests that this period be extended through August 31, 2017, with a total cost to the Borough of Forty-Six Thousand Dollars (\$46,000.00) (Task One being Twenty-One Thousand Dollars (\$21,000.00) and Task Two being Twenty-Five Thousand Dollars (\$25,000.00)), a copy of said letter being maintained in the Office of the Borough Clerk, the contents of which are incorporated herein; and,

WHEREAS, the Borough of North Plainfield is desirous of amending the authorizing resolution and the Professional Services Agreement to extend the period of the Agreement through August 31, 2017 for a total sum of Forty-Six Thousand Dollars (\$46,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey, that the Borough Council does hereby authorize the Mayor and Clerk to execute an Amended Professional Services Agreement to reflect the extension of time for the Agreement through August 31, 2017 for a total sum of Forty-Six Thousand Dollars (\$46,000.00).

BE IT FURTHER RESOLVED that the execution of this Amended Professional Services Agreement shall be subject to the Certification of the Borough's Chief Financial Officer as to the availability of funds for payment for same.

BE IT FURTHER RESOLVED that the award is made pursuant to and consistent with the Local Public Contracts Laws of the State of New Jersey.

RESOLUTION NO. 07-10-17-01e RESOLUTION OF THE BOROUGH COUNCIL APPROVING PAYMENT NO. 4 (FINAL) AND THE CLOSING OUT OF THE CONTRACT AND RELEASE OF RETAINAGE TO YOUR WAY CONSTRUCTION INC. FOR THE PROJECT KNOWN AS SOMERSET STREET & PEARL STREET MUNICIPAL PARKING LOT

WHEREAS, the Borough of North Plainfield previously awarded a contract for certain municipal parking lot improvements with regard to a project known as "Somerset Street & Pearl Street Municipal Parking Lot" (hereinafter referred to as the "Project"), with said contract having been awarded to Your Way Construction Inc., whose main offices are located at 404 Coit Street, Irvington, New Jersey 07111 (hereinafter referred to as the "Contractor"); and,

WHEREAS, David J. Testa, P.E., C.M.E., C.P.W.M., of Grotto Engineering Associates, LLC (hereinafter referred to as the "Engineer"), on behalf of the Borough, has reviewed the Contractor's submission for Payment No. 4 (Final) in the total amount of Six Thousand Six Hundred Two Dollars and Thirty-Seven Cents (\$6,602.37) and for the total closeout of the Project, which includes the release of any of the Contractor's retained funds held by the Borough for the Project; and,

WHEREAS, the Engineer, on behalf of the Borough, has reviewed the Contractor's request for Payment No. 4, reducing the net amount of the completed project in the total amount of One Thousand Five Hundred Seven Dollars and Thirty-Seven Cents (\$1,507.37) to One Hundred Seventy Thousand Six Hundred Seventy-Six Dollars and Fifty-Two Cents (\$170,676.52); and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esq., and the offices of Eric M. Bernstein & Associates, L.L.C. has reviewed the Engineer's and the Contractor's submissions and accepts same based on the recommendations of the Engineer.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the request for Payment No. 4 (Final), dated June 23, 2017, and Closeout of the Project known as Somerset Street & Pearl Street Municipal Parking Lot, which includes the release of any retainage held by the Borough, is approved in the total amount of Six Thousand Six Hundred Two Dollars and Thirty-Seven Cents (\$6,602.37), which Final Payment Request and Closeout request is incorporated herein by reference as if same was fully set forth within, and payment for same is authorized to be made to the Contractor, without the need for any further action of this Borough Council; and,

BE IT FURTHER RESOLVED that this Resolution shall be subject to the Certification of the Borough's Chief Financial Officer as to the availability of funds for payment for same.

BE IT FURTHER RESOLVED that the award is made pursuant to and consistent with the Local Public Contracts Laws of the State of New Jersey.

RESOLUTION NO. 07-10-17-01f RESOLUTION AUTHORIZING THE MAYOR AND/OR THE MAYOR AND BOROUGH CLERK AND/OR THE BOROUGH ADMINISTRATOR TO ACT AND EXECUTE AGREEMENTS ON BEHALF OF THE BOROUGH DURING THE TIME THE BOROUGH COUNCIL IS NOT IN SESSION

WHEREAS, there are certain periods of time when the North Plainfield Borough Council is not in session and no meetings are scheduled and/or held by the Borough Council; and,

WHEREAS, during such time when the Borough Council is not in session, or where otherwise appropriate and/or necessary, certain actions may need to be taken by the Borough of North Plainfield with respect to paying bills, executing agreements and other such items; and,

WHEREAS, the Borough Council will only be holding two (2) meetings during the time period between July 10, 2017 and September 11, 2017; and,

WHEREAS, the Borough wishes to authorize the Mayor and/or the Mayor and Borough Clerk and/or the Borough Administrator to take any necessary action on behalf of the Borough during the time the Borough Council is not in session including, but not limited to, paying bills and executing agreements on behalf of the Borough.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Mayor and/or the Mayor and Borough Clerk and/or the Borough Administrator are hereby authorized to pay bills, execute any and all agreements and/or take any other action on behalf of the Borough that becomes necessary during the time the Borough Council is not in session and no meetings are scheduled and/or held by the Borough Council.

HEARING:

RENEWAL OF PLENARY RETAIL CONSUMPTION LICENSE NO. 1814-33-007-008 (DOMBAR LLC, d/b/a INTERNATIONAL CLUB & SPORTS BAR)

The Clerk read the above title.

Mr. Bernstein conducted the hearing, explaining that it was a continuation as the objector's presentation had been started at the July 10, 2017 meeting.

Mr. Stephen A. Caputo, Esq. identified himself as representing Dombar LLC, while Mr. Phillip Rosenbach, Esq. advised that he was representing the owners of Somerset Square.

Joshua Smallwood, Jr., stated that he is a security officer at the International Club & Sports Bar stationed at the main entrance to check ID's. He explained that Mr. Long had installed an eight foot fence between the properties which prohibits their view into the Somerset Square parking lot and does not allow them to stop their patrons from illegally parking there. Under questioning from Mr. Caputo, he explained that a large fight had occurred in 2016, although it was not clear if all of the participants were their patrons.

Danny Dominguez, manager of the International Club & Sports Bar, began by responding to and disagreeing with several portions of Mr. Long's affidavit. Referencing the surveillance videos provided by Mr. Long, he assured that most late-night traffic in the Somerset Square parking lot was due to taxicabs. Addressing Mr. Long's notion that Somerset Square maintains a safe shopping environment, he advised that shoplifting, disorderly persons, loitering and public urination often occur overnight because the Quick Chek remains open twenty-four hours. He further advised that five arrests had been made in Quick Chek since the last meeting. Addressing Mr. Long's statement that beer bottles found on his property could only have come from the bar patrons, Mr. Dominquez chose to conduct his own surveys of the property. Over several weeks' time, he detailed having found just a few beer bottles, noting that he does not sell beer cans.

Addressing the Computer Aided Dispatch records he had submitted as evidence, Mr. Dominguez conceded that 2014 saw the heaviest police call volume, mostly due to various events held by renters of the banquet hall. He advised of a carjacking and shooting which occurred in the Quick Chek parking lot during his establishment's off hours. Police calls to his establishment had subsided each year since then, he reported. Detailing aspects of his TIPS (training for intervention procedures) certification, he assured that he has made every effort to maintain a clean and safe establishment.

RECESS:

Mr. Bernstein called for a recess at 8:35 p.m., with the hearing being reconvened at 8:45 p.m., all Council Members again marked present that were present at the initial roll call.

RECONVENE:

Mr. Bernstein advised that Councilman Righetti would recuse himself as he had not reviewed all of the evidence and did not attend the previous meeting.

Mr. Dominguez shared his concerns with the surveillance videos Mr. Long provided, specifically that they may have been edited. Illegal parking at Somerset Square has occurred for years and lack of adequate signage only exacerbates the issue. Stressing that his patrons are advised never to park in Mr. Long's lot, he further noted that he had installed signs on his property indicating same. Taxicabs to and from his business are asked to use his driveway, he concluded.

Mr. Bernstein called for a brief sidebar at 9:10 p.m. with Messrs. Caputo and Rosenbach, and reconvened the hearing at 9:12 p.m.

Mr. Dominguez voiced his displeasure with Mr. Long's claim that all of the problems in the Somerset Square lot are a direct result of his establishment. Again stressing that he and Mr. Weber have made every effort to run a good, clean establishment, he reported that nothing short of closing his business would be satisfactory to Mr. Long.

RECESS:

Mr. Bernstein called for a recess at 9:48 p.m., with the hearing being reconvened at 9:53 p.m., all Council Members again marked present that were present at the initial roll call. Mr. Righetti again recused himself.

RECONVENE:

Mr. Bernstein presented to Messrs. Caputo and Rosenbach a Notice of Final Decision between Dombar, LLC and ABC.

Mr. Caputo began by stating that a great deal of testimony had been heard and a great amount of evidence submitted. Mr. Long's claim that all problems in the Somerset Square shopping center are a direct result of the International Club & Sports Bar is simply not true. He noted that the Somerset Square parking lot is adjoined by another licensed establishment and a package goods store is a little over a block away. Messrs. Dominguez and Weber have made every effort to run a clean and safe establishment. They do not allow illicit events and they have even made improvements to the immediate surrounding area.

Mr. Rosenbach began by stating that a liquor license is a privilege in New Jersey. The license holder is responsible for the patrons' activities directly outside of the establishment and the videos disclose that there have been incidents on his client's property. Liquor-licensed establishments must be held to a high standard and the International Club & Sports Bar is not meeting that standard.

Motion to close public hearing by Mr. Stabile, seconded by Ms. Schaefer and on voice vote carried all four in favor.

Ms. Miller presented the following Resolution and moved its adoption:

RESOLUTION NO. 07-10-17-02 BE IT RESOLVED by the Council of the Borough of North Plainfield that prior to the adjournment of this meeting it shall convene in executive session from which the public will be excluded for the purpose of discussion on:

ATTORNEY/CLIENT PRIVILEGE

Exclusion of the public for this purpose is specifically permitted by <u>N.J.S.A.</u> 10:4-6 et seq. The contents of this discussion will not be disclosed until such time as the disclosure of same will not adversely affect the public interest and upon resolution of the Council. Formal action may be taken following end of executive session.

Seconded by Mr. Stabile and on Roll Call carried all four voting aye.

EXECUTIVE SESSION

Motion to come out of Executive Session by Mr. Stabile, seconded by Ms. Miller and carried unanimously.

Council President La Ronde reconvened the meeting at 11:16 p.m. with all four council members present.

Mr. Bernstein read the following Resolution:

RESOLUTION NO. 07-10-17-03 WHEREAS, the Applicant below has applied for a renewal of its Plenary Retail Consumption License for the period of July 1, 2017 through June 30, 2018 and the submitted application forms are complete; and,

WHEREAS, an objection was raised by a neighboring property owner as to the propriety of the Applicant's renewal of his liquor license, in which evidence and testimony were presented by both the objector and the Applicant; and,

WHEREAS, during the hearing Applicant, through his counsel, admitted that he had submitted deliberately misleading applications to the State ABC and the Borough of North Plainfield for renewal by failing to disclose a fifty (50%) percent owner of the Applicant in 2014, 2015, 2016 and 2017, until a correct application in conjunction with a change of ownership application was filed on June 15, 2017; and,

WHEREAS, after hearing all of the testimony and receiving all of the evidence and after having deliberated as to the application, the Borough Council of the Borough of North Plainfield determined that the objector's evidence/testimony did not meet the standard for a finding of the preponderance of credible evidence to deny the license renewal of Applicant, but the Applicant's applications for renewal in 2014, 2015, 2016 and 2017 were deliberately misleading as to ownership of the Applicant that shows violations of N.J.S.A. 33:1-25 and N.J.A.C. 13:2-2.14(a) and N.J.A.C. 13:2-2.14(b).

WHEREAS, based on prior written agreement with the State ABC that resulted in disciplinary penalties being imposed, the Borough Council determined the violations of Title 33 of New Jersey Statutes and Title 13 of the New Jersey Administrative Code were second (2nd) violations; and,

WHEREAS, the Borough Council found the actions of the Applicant guilty as to its renewal applications as set forth below.

NOW THEREFORE, BE IT FURTHER RESOLVED that Applicant is found guilty, as second (2nd) violations of the following:

- (1) <u>N.J.S.A.</u> 33:1-25 and <u>N.J.A.C.</u> 13:2-2.14(a) Failure to timely notify of a change in fact on the license application <u>three (3) days</u>;
- (2) N.J.S.A. 33:1-25 and N.J.A.C. 13:2-2.14(b) Failure to notify of a corporate structure change three (3) days; and,
- (3) <u>N.J.S.A.</u> 33:1-25 Failure to disclose or false, misleading or inaccurate answer to a question on an application, which would not by itself result in a disqualification for license twenty (20) days;
