ADMINISTRATION:

Staffing:

The Police Department is operating below its authorized strength of 48 sworn Officers, and 6 fulltime civilian personnel. Staffing and deficiencies:

- 3 police officers
- 1 Lieutenant's position
- 2 administrative assistants (chief and records), have been reduced to 29 hour part-time positions.

Injured Officers:

- Officer Brid continued to work on light duty since March 27, due to a surgery he had on November 3; a result of an on duty accident he had on December 9, 2014. As of April 30, he was out of work for 74 days and on light duty for 21 days.
- Sergeant McKay suffered serious injuries when he was involved in an off duty motor vehicle accident on February 3. As of April 30, he was out of work 56 days.
- Officer Jean-Baptiste was placed on administrative leave March 6, due to a complaint requiring an investigation. As of April 30, he was out of work for 32 days.

Promotions, New Hires and Retirements

- There were no new hires, promotions, or retirements in April.

A Sample of Investigations & Arrests

On March 20, 2017 a person came in to police headquarters to report that there was a person possibly practicing dentistry out of an apartment. An investigation was launched and it was determined that the person was in fact running a dentist business out of an apartment with crude tools and residential furniture as his work area. A search warrant was obtained and an arrest warrant and the male was charged with possession of a controlled dangerous substance and no license to practice. He was charged and released and is awaiting the court proceedings.

On April 1, 2017 a resident reported another delivered package theft from a porch. During the investigation a camera captured the suspect leaving the area. This suspect was known to officers of this agency for similar crimes. A summons was issued for him and served on him at the Somerset County Jail where he was on unrelated charges. He is awaiting the court proceedings.

On April 9, 2017 patrol units responded to a local business for a recent shoplifting incident. While searching and finding the suspect search incident to arrest he was found to be in possession of over 25 prescription pills in a prescription bottle not for him. The suspect was charged with the possession of the pills and released and is awaiting the court proceedings.

On April 11, 2017 a resident reported another delivered package theft from a porch. The victim has a home security camera system on the residence and captured a quality image of the suspect and his vehicle. The pictures were posted to the town and police department Facebook page and requested assistance from the public. The next day the suspect was identified and upon speaking with him numerous other items were recovered that were not his or his families. Almost all of that property was returned to grateful owners and the suspect was charged and released awaiting the court proceedings.

Community Outreach

The Community Forum meeting was attended by Detective Domizi. Domizi also was on hand at the Valley National Bank Shredder truck event where people were encouraged to shred important documents to stop identity theft. Detective Domizi also attended a two day training seminar presented by the National Center for Missing and Exploited Children. The unit also sent out 31 False Alarm Activation letters to first time activations and 3 False alarm warning notices.

Narcotics Strike Force

The Narcotics Strike Force were in town for 10 hours doing surveillance and conducting follow up interviews on complaints received from residents.

Adjudications & Judicial Proceedings

On April 7, 2017 Nicholas J Alleyne was sentenced to 4 years in state prison for his role in a robbery on January 21, 2009 in the boro. Alleyne was sentenced by Superior Court judge, honorable Bury in Somerville.

On April 21, 2017 Nathaniel Johnson was sentenced to 5 years in state prison for his role in the above robbery on January 21, 2009 in in the boro. Johnson was also sentenced by Judge Bury of the Superior Court in Somerville.

On April 11, 2017 Toni Bolton was sentenced to 3 years in state prison for possession of a Controlled Dangerous Substance. Bolton was sentenced by Judge Reed of the Superior Court in Somerville.

Members of the Detective Bureau testified before the Superior Court Grand Jury three times in April.
