

Hurricane Irene Resources

**Were you or someone you know affected by Hurricane Irene?
Following is a list of resources and services that are available.**

County residents that were affected by the Hurricane are encouraged to call 211 or go to the website (www.nj211.org) for more detailed information about the programs and services that are listed below.

American Red Cross – individuals needing assistance from Red Cross are encouraged to call 609-951-2102.

Clean Up- households and small businesses that need assistance with clean up should call and register with 211.

Counseling- trained counselors are available to speak with anyone who is dealing with stress that is a result of the Hurricane. Anyone who wants services can call Family and Community Services (732-356-1082) or the Richard Hall Community Mental Health Center (908-725-2800).

FEMA- individuals and business owners who sustained damage losses can begin applying for assistance by registering online at www.disasterassistance.gov or by calling 800-621-FEMA (3362). Affected households must apply within sixty days of the hurricane. The Operations Center is at 27 Warren Street, Somerville; the hours of operation are 8 am- 6 p.m., seven days a week.

Food- The Food Bank Network (732-560-1813) can provide food and personal supplies. County residents who are not currently SNAP/Food Stamp recipients and suffered hurricane-related losses may apply for Disaster SNAP/Food Stamp benefits. For more information call the Board of Social Services (908-526-8800) or visit the SNAP website at www.njsnap.org. The application deadline is September 15.

Legal Assistance- Legal Services of Northwest Jersey (908-231-0840) can answer questions about tenancy and other legal issues.

Medical Services- SHIP (87 E. High Street) operates an eye clinic that provides complete eye exams on the first Thursday of each month. To schedule an appointment, call SHIP at (908)393-9545. SHIP also operates a medical clinic that is open on the first and third Wednesday of each month from 12:30 p.m. until 4 p.m. Walk-ins are accepted. There is no fee for either of these services. The Food Bank Network can provide assistance with prescription costs as well -call 732-560-1813.

Rental Assistance- the Homelessness Trust Fund can provide up to twelve months of rental assistance and case management to families that are income eligible and meet the other program requirements. For more information call the Community Development Office at (908)-541-5756.

Seniors- the Somerset County Office on Aging and Disability Services (908-704-6346) can provide case management to seniors and disabled County residents.

Tax Relief- Filing and payment relief is available to residents and small business owners. Individuals can consult IRS Publication 2194 for information about how to claim casualty losses on property that was destroyed by a natural disaster; small business owners can consult IRS Publication 2194B.

Volunteer- Individuals that would like to volunteer should call the Governor's Office on volunteerism (609) 633-9627, go to www.volunteernewjersey.org/vnj/ or call Suzanne Anderson at the Greater Somerset Chapter of Red Cross at (908)725-2217.
