<u>Continuing Care Retirement Communities (CCRC)</u> CCRCs include a combination of independent living, assisted living and nursing facilities. Residents' transition from independent living to assisted living or nursing care accommodations within the community as their needs change. Normally require an entry fee, and offer a range of services tailored to residents' needs.

Residential Health Care (RHC), Long Term Care (LTC) and Sub-Acute Care (SAC) Facilities RHC, LTC and SAC facilities are licensed by the State of NJ to provide health care, maintenance and monitoring in a residential setting. The level of nursing, personal care and support services vary depending on the facility and licensing requirements.

Active Adult Retirement Communities (AARC) Rental (apartments) or for-purchase (units) designed and constructed for senior occupancy. Generally, at least one member of the household must be 55 years of age or older with no children under the age of 19 years in permanent residence, pursuant to the Federal Fair Housing Act of 1998 and amendments thereto, including but not limited to the Housing for Older Persons Act of 1995. Often gated, these communities provide recreation facilities. Common buildings and grounds are maintained by Homeowners Associations (resident fee required).

Assisted Living Facilities (AL) Residential facilities licensed by the State of NJ that provide private or shared rooms, suites or apart. plus a specific range of personal care and support services from which residents may choose.

Shared Living Residences (SLR) SLRs provide both private and shared living space, usually a private bedroom and shared living, dining, kitchen and bathrooms. May be restricted to L/M eligible seniors.

<u>Low/Moderate Income (L/M) Age-Restricted Housing</u> L/M residential accommodations for seniors that generally do not include nursing, personal care or other support services, which are available to income qualified seniors, pursuant to federal Department of Housing and Development (HUD) and NJ fair Housing act and Council on Affordable Housing (COAH) rules and regulations.

<u>Market Rate (MR) Age-Restricted Housing</u> MR residential accommodations for seniors where HUD and COAH income eligibility requirements do not apply.

Notes: There are approximately 104 Rooming and Boarding Homes in Somerset County that can accommodate 513 occupants. Some facilities can be associated with more than one category, for example, Old Mill Manor can be used as either RHC or AL facility.
